- ❖ Students with less than 27 credits between Fall 2018 & Spring 2019 must provide Summer 2019 verification of enrollment with enough credits to earn the 27 credits for the ticket.
- ❖ Students within 6 months of graduation are not eligible to the annual ticket. If you receive an annual ticket and graduate within 6 months, you will need to repay the annual ticket received from your graduation allowances.
